The federal compliance compensation provision you requested appears as section 38 in the current draft of the admin bill, LCPR09-010-2, which was sent to you a few days ago. I think the citations to the treasury regulations in that provision are wrong. In the LCPR draft, line 26.6 currently reads, "1.415(c)-2(b) and excluding items described in treasury regulation section 1.415(c)-2(c)." Based on an on-line review of federal regulations I think it should be "1.415-2(d)(2) and excluding items described in treasury regulation section 1.415(c)-2(c)."

Please review and let me know which citations should be in the final bill draft.
