# Potential Amendments to the 2015 Omnibus Retirement Bill 

## Article 1

LCPR1504A-5A, requested by MSRS, reduces the salary increase assumption for the Judges
Retirement Plan (page 3).

## Articles 2 and 3

LCPR1504A-3A, requested by MSRS, is intended to clarify the timing for interest calculation (page 5).

LCPR1504A-6A, requested by TRA, extends an exception to the interest rate reduction to Chapter 356 provisions when TRA is involved (page 7).

## Article 4

LCPR1504A-14A, requested by SPTRFA, and in lieu of the -1A amendment (agenda item \#7), replaces the up to 5\% CPI-based post-retirement adjustment at $90 \%$ funded with $2.5 \%$ flat rate adjustment (page 9).

LCPR1504A-4A, requested by MSRS, PERA, and TRA, clarifies the minimum waiting period for an initial post-retirement adjustment (11).

## Articles 8 and 10

LCPR1504A-7A, suggested by Commission staff, clarifies a reference, eliminates the Secretary of State filing, and removes an unnecessary reference to PERA in the Roseville provision (page 13).

## Article 11

LCPR1504A-8A, requested by the Legislative Coordinating Commission, clarifies the part-time legislative employee issue and revises the retroactive effective date (page 15).

Subd. 9. Calculation of postretirement adjustments. (a) This subdivision applies if the requirements of subdivision 8 has expired, paragraph (c), have been satisfied.
(b) A percentage adjustment must be eomputed and paid under this subdivision to eligible persons under subdivision 7. This adjustment is determined by reference to the Consumer Price Index for urban wage eamers and clerical workers all items index as reported by the Bureat of Labor Statisties within the United States Department of Labor each year as part of the determination of anmal cost-of-living adjustments to recipients of federal old-age, survivors, and disability insurance. For ealeulations of postretirement adjustments under paragraph (e), the term "average third quarter Constmer Priee Index value" means the sum of the monthly index values as initially reported by the Bureat of Labor Statisties for the months of July, August, and September, divided by three.
(e) Before Jantary 1 of each year, the exeeutive director must ealeulate the amount of the postretirement adjustment by dividing the most reeent average third quarter index value by the same average third quarter index value from the previous year, subtraet one from the resulting quotient, and express the result as a pereentage amount, which must be rounded to the nearest one-tenth of one pereent.
(d) (c) The amount ealeulated under paragraph (e) of 2.5 percent is the full postretirement adjustment to be applied as a permanent increase to the regular payment of each eligible member on January 1 of the next calendar year. For any eligible member whose effective date of benefit commencement occurred during the after January 1 of the calendar year immediately before the postretirement adjustment is applied, the full increase postretirement adjustment amount must be prorated on the basis of whole ealendar quarters in benefit payment status in the ealendar year prior to the Jantary 1 on
which the postretirement adjustment is applied, caleulated to the third deeimal place reduced by 50 percent.
(e) The adjustment must not be less than zero nor greater than five pereent.
