The Second Amendment's language is clear: the right "shall not be infringed," indicating it exists independently of state permission. This aligns with the Founding Fathers' intent, as articulated in historical writings like those of James Madison and Thomas Jefferson, who viewed an armed populace as essential for preserving liberty and guarding against tyranny. The Federalist Papers, particularly No. 46, emphasize the people's ability to resist oppressive government through arms as a core check on power. The Supreme Court has reinforced this interpretation. In District of Columbia v. Heller (2008), the Court ruled that the Second Amendment protects an individual's right to possess firearms for self-defense, unconnected to militia service.

McDonald v. City of Chicago (2010) further clarified that this right applies to state and local governments through the Fourteenth Amendment, cementing its status as a fundamental right akin to free speech or due process. Opponents often argue that the amendment's militia clause limits its scope or that modern conditions justify restrictions, framing gun ownership as a privilege subject to regulation. However, the historical context—rooted in Enlightenment principles of individual liberty and distrust of centralized power—supports the view that the right predates and transcends government control. The phrase "the right of the people" mirrors language in other amendments, consistently denoting individual protections. Privileges, like driving or voting, can be revoked or conditioned by the state. Rights, by contrast, are inalienable, though not absolute—courts have upheld limited regulations (e.g., background checks) that don't unduly burden the core right. The Second Amendment in the Bill of Rights, alongside freedoms of speech and religio

burdening law-abiding gun owners. The Second Amendment's intent, as seen in writings from Madison and Jefferson, was to ensure individuals could defend themselves and resist tyranny, not to enable criminality. Courts, like in Heller (2008), affirm this individual right for self-defense. Restricting law-abiding citizens—through blanket bans or excessive regulations—disarms those least likely to commit crimes, while criminals, undeterred by laws, remain armed. My name is Erik D. Pakieser. I spent close to 20 years in law enforcement and under the Federal Law Enforcement Officers' Safety Act I am authorized to carry a firearm nationwide. I also have a Minnesota Permit to Carry. I am also a veteran of the US Army Military Police and have been a professional firearms instructor for over 30 years. I am the Principal and Owner of QSI Training, and train approx.. 200 students per year in the safe and responsible use of firearms for self-defense.

For the past 25 years, I have been employed by the State of Minnesota and one of my job responsibilities is security for an agency with offices in the Capitol Complex. I any statements I make here are my own opinion as a private citizen and not those of my employer. I am a member of the Minnesota Gun Owners Caucus and trust them to represent me.

I am contacting you to express my opposition to any firearm bans at the State Capitol or Capitol Complex. My work brings me to the Capitol Complex on a regular basis and I am familiar with security issues at the Capitol. Members of the State Patrol working at the Capitol have stated to me on multiple occasions there has never been an issue with anyone legally carrying a firearm at the Capitol. People who legally carry firearms at the Capitol have been permitted to do so since it was built.

I am not indifferent to concerns about security, but creating TSA-style weapons checks to enter the Capitol will not be effective. There are multiple entrances to the Capitol, and closing these entrances to funnel employees and citizens to a crowded and time-consuming checkpoint will not improve security. Furthermore, technology, redesign, maintenance, and personnel costs for such a checkpoint will easily cost millions of dollars at a time when the State is experiencing a multi-billion dollar shortfall. Banning guns in the Capitol would also create legal issues. Under the US Supreme Court "Bruen" ruling, such a prohibition would likely be unconstitutional and result in costly lawsuits. State law would also have to be amended for such a policy to move forward.

Last, but not least, such a policy would endanger the safety of our citizens. Crime around the Capitol has been a concern and appears to be increasing. Forcing citizens to store guns in their cars when visiting the Capitol presents opportunities for guns to be stolen, and leaves these citizens stripped of their self-defense tools when visiting the Capitol.

To summarize, a Capitol gun ban would inconvenience and discourage citizen participation in the Legislative process, increase the risk of violent crime and vehicle break-ins, be ultimately ineffective in increasing security and be fiscally irresponsible.
