Call to Order

Chair Flanagan called the meeting to order at approximately 9:02 a.m.

Approval of Minutes

Review and Approval of the Advisory Committee on Capitol Area Security Annual Report - January 15, 2025

Captain Roeske and Director Suchy provided an overview of the Annual Report, summarizing recent security initiatives, ongoing projects, and recommendations for future improvements. Committee members discussed elements of the report, including funding and project scope.

Representative Moller moved to approve the report, seconded by Senator Westlin. The motion passed with four members voting in favor and two opposed.

Department of Public Safety Staffing Update

Colonel Bogojevic and Captain Roeske provided an update on staffing for Capitol Security, including recent hires and anticipated additions to both State Trooper and Security Officer positions. Chair Flanagan called for questions; none were raised.

House and Senate Sergeants at Arms Update

Chief Sergeant-at-Arms Hodapp and Chief Sergeant-at-Arms Lindquist provided updates on recent training initiatives, security procedures, and upcoming planning efforts for their respective operations. Chair Flanagan called for questions; none were raised.
