Call to Order

Chair Flanagan called the meeting to order at 12:35pm.

Approval of Minutes

Chair Flanagan called for a motion to approve the September 22, 2025, ACCAS meeting minutes. Representative Nash moved to approve the minutes. The minutes were unanimously approved.

The Axtell Group, LLC Capitol Security Assessment Update

Chair Flanagan introduced Todd Axtell and John Kirkwood from the Axtell Group, which is conducting a comprehensive security assessment of four buildings on the Capitol Complex. They provided an update on the four facility-specific reports and noted that a fifth, public facing report consolidating key recommendations will follow. The group reported on what methods are being

employed in the assessment. The committee was informed that the Capitol Building phase of the project has nearly been completed, which will be followed by the Senate Building, Centennial Office Building, and the Judicial Center. Committee members asked questions and discussion followed.

Update from Department of Public Safety

Chair Flanagan invited Lt. Col. Geiger to provide an update from the Department of Public Safety. They shared information regarding staffing changes and personnel. Other topics included security upgrades and collaboration with other states. Captain Roeske covered ongoing issues, trainings, planning, and emergency drills across the Capitol Complex. Committee members asked questions and discussion followed.

Update from Senate and House Sergeant-at-Arms

Chair Flanagan invited the Sergeants-at-Arms from the Minnesota Senate and House of Representatives to provide updates. Sven Lindquist, Chief Sergeant-at-Arms for the Senate, and Keith Boser, Deputy Chief Sergeant-at-Arms for the House, shared information regarding staffing, listening sessions, key-card upgrades, and physical security initiatives. Chair Flanagan called for questions; none were raised.

National Conference of State Legislatures (NCSL) Capitol Security: Policies and Practices Emily Ronco, Policy Specialist at NCSL, presented virtually on Capitol security policies and practices. Topics included decorum, screening processes, firearm storage, and Capitol complexes. Chair Flanagan called for questions by topic, and discussion followed.

Public Comment

Rick Heller provided a public comment. No additional comments were made.

Representative Nash requested time for additional questions. Chair Flanagan agreed, and discussion followed.
