General Information

- In 1993, was informally created
- In 1995, began providing services to all the health related licensing boards
- In 1996, the Emergency Medical Services Regulatory Board requested administrative services from ASU. Moving from MN Dept. of Health
- In 2005, the Board of Barbers and Cosmetology requested administrative services from ASU. Moving from MN Dept. of Commerce
- We jointly purchase and share equipment
 - network servers, printers and copiers, audiovisual equipment, recording systems, an electronic public notice board that is located in the lobby of the building and other IT equipment and services.
- The collaboration greatly increases the efficiency of all the boards and results in significant cost savings to all boards.

We are small, efficient, self supporting and a model for small agencies and boards.






Minnesota Health-Related Licensing Boards: Overview

- Overview of Administrative Services Unit
 - HLRBs work cooperatively to achieve efficiencies
 - Co-located in the same office building
 - Share in back office common functions
 - Response to previous Administration reviews
 - 1999 OLA Report, Bonelli Report
 - Work with the Health and Human Services Committees
 - Jointly fund the Administrative Services Unit (ASU)
 - For all Current Sunset Health Boards not funded by tax revenue –NO General Fund dollars
 - Funded exclusively through fees deposited in the Special Revenue Fund

Collaboration and Efficiency

- Voluntary Health Care Provider Program
- Council of Health Boards
- Centralized Retirement Funds
- Centralized legal fees for contested cases Centralized back office and IT staff
- Centralized Prescription Monitoring
- National model for decentralized sole collaborative regulatory model
- Highly regarded by previous Administration presented model to other like agencies
- States mirroring Minnesota Model
- Pew Commission
- Boards (non-health related) moved out of larger agencies to ASU
- Final Report: Any recommendations will be reviewed by the individual board, or ASU if staff only or the Council of Health Boards if you desire revisions being driven by the board members

Minnesota Health-Related Licensing Boards: Administrative Services Unit – Programs

- Volunteer Health Care Provider Program (Minnesota Statute 214.40)
 - Provide malpractice insurance coverage to physicians, physician assistants, dentists, dental hygienist, and nurses
 - Register non-profit organizations/clinics in the program
 - This program is funded by a direct appropriation from the state government special revenue fund. Directly from fees collected by the Board of Medical Practice, Board of Nursing and Board of Dentistry
- Council of Health Boards (Minnesota Statute 214.025)
 - Legislatively created
 - Common issues involving board members and citizens
 - Expert Occupational Review of proposed licensing boards
- Health Professionals Services Program (Minnesota Statute 214.31)
 - ASU provides all financial and business office processes
 - This program is funded by a direct appropriation from the state government special revenue fund. Directly from fees collected by all of the health-related licensing boards, EMSRB, Cosmetology, Barbers and the Dept. of Health
- Biennial Reports (Minnesota Statute 214.07)
 - ASU compiles all the boards reports into a single report to legislature
