- The Commission was created by laws of 2006, Chapter 282, Article 11, Sec. 14.
- Section 5 of the same article appropriated \$50,000 in FY 07 for the Commission
- Section 25 set forth a fee schedule, and Section 29 gave authority to the Commission to expend fees it collected

# Commission Members appointed by Governor

- Four members with knowledge of Boxing
- Four members with knowledge of Mixed Martial Arts (MMA)
- One retired Judge
- Executive Director
  - Operations Manager Hired by Exec Dir

- The Commission has two full-time FTEs
  - Executive Director
  - Operations Manager
- Prior to 2008 staffing consisted of:
  - One .5 FTE Executive Director
  - Volunteer staff members

The mission of the Commission is to protect the health and safety of the combatants and to ensure the fairness of boxing and Mixed Martial Arts (MMA) events

#### Core functions:

- Sanction all professional boxing, amateur and professional MMA bouts in Minnesota
- License all fighters, trainers, announcers, judges, inspectors, referees, timekeepers, and promoters
- Monitor and train judges, referees and inspectors

#### Core activities continued:

- Monitor all activities during an event
- Handle grievance issues
- Hold bi-monthly public meetings
- Issue penalties and suspensions for violations
- Abide by the Association of Boxing Commissioners (ABC) rules and regulations

# The Commission monitors activities to ensure that:

- Fighters are not exposed to HIV, Hepatitis B or C viruses
- Fighters & opponents are matched appropriately
- Professional Fighters are weighed the night before bout
- Amateur fighters are weighed day of bout
- Fighters undergo a pre-bout and post-bout physical
- Physicians are at cage-side to prevent serious injury
- Inspectors are available to monitor the wrapping of fighters' hands and to ensure safety in the locker room


# Combative Sports Commission Fighter Safety

- All fighters must serve a mandatory 7-day rest period
- Fighters receive 30-day suspensions for too many strikes
- Fighters are suspended 30-days following a TKO
- Fighters are suspended 60-days following a KO
- Fighters are suspended 45-60 days if they require stitches
- Suspended fighters cannot fight in another state

#### **ALL SUSPENSIONS ARE MINIMUM SUSPENSIONS**

With Commissions in Iowa, North Dakota and Wisconsin, it is not possible for fighters to cross state lines and fight in unsanctioned events

- Commission events are held on weekends and we have held events in the following areas

- The Commission's main focus is:
  - to protect the health and safety of the fighters and;
  - to ensure safe and fair contests for both the fighters and the fans.
- There have been no serious injuries of fighters since the Commission was created, and we continually take steps to prevent injury to fighters.

#### Consequences of Abolishing Commission

- Safety and health of the combatants would no longer be monitored or enforced
- The number of unsanctioned events would dramatically increase
- Jurisdictions that previously considered banning MMA would do so
- 4. Revenue (approximately \$300,000+) from license and event fees that Minnesota currently receives, would stop and would flow into Iowa, North Dakota, and Wisconsin.
