## PROPOSED RULES OF THE SUNSET ADVISORY COMMISSION As proposed November 21, 2011

1	1.0 AUTHORIZED PROCEDURAL MANUAL. Except as otherwise provided by
2	these rules, the rules of parliamentary procedure contained in Mason's Manual of
3	Legislative Procedure govern the Sunset Advisory Commission ("Commission").
4	
5	2.0 OFFICERS. The Commission shall elect its own officers including a chair and vice
6	chair, by majority vote of those members present. Officers serve through January 7,
7	2013.
8	
9	3.0 MEETINGS. All meetings of the Commission are open to the public.
10	
11	3.1 The chair of the Commission shall, as far as practicable, give three days notice of
12	any meeting. The notice shall include the date, time, place and agenda for the meeting.
13	
14	3.2 The chair of the Commission shall cause minutes to be kept. The minutes shall include:

16	<ul><li>(a) The time and place of each hearing or meeting;</li><li>(b) Commission means have an example.</li></ul>
17	(b) Commission members present;
18	(c) The name of each person appearing, together with the name of the person, agency or
19	organization represented;
20	(d) The language of each motion, the name of the member making the motion, and the
21	result of any vote upon the motion, including the ayes and nays when a roll call is
22	demanded;
23	(e) Other matters related to the work of the Commission.
24	Minutes shall be approved at the next regular meeting of the Commission.
