Meeting was called to order at 2:00 p.m. by Chair Senjem. A quorum was present.

Approve Minutes from 6/2/22 Meeting: Motion by Karl Samp and seconded by Sally Fineday to approve the June 2, 2022 meeting minutes as presented. Motion carried.

Informational Presentation – Land and Water Conservation Fund: Senator Senjem welcomed Audrey Mularie, PAT Grant Coordinator from the Department of Natural Resources. An overview of the Land and Water Conservation Fund in Minnesota was provided. There are two types of grants available; 1) National Outdoor Recreational Legacy Partnership Program (ORLP) – grant application information is now available. This program is for cities with a population of 30,000+, or other entities abutting a city of 30,000+. Full details are available at -

https://www.dnr.state.mn.us/grants/recreation/outdoor_rec.html. Commission discussion followed. A suggestion was made to send information on these grants, especially the Local Parks and Trails Program, to MN GRR partners and stakeholders. Regional members could also share with partners in their regions. MnDOT noted that these funding sources could be mentioned during their project meetings with local partners.

Budget Report: The budget reports in the meeting packet were referenced followed by discussion and consensus approval.

Regional Meetings/Elections: Chris Miller reported that since regional commissioner terms remain at two years, regional meetings and elections will be due for the Elk River to Hastings and Hastings to Iowa Border regions before the end of 2022. There was discussion about in person or virtual meetings, with benefits noted to both approaches.

National MRPC Annual Meeting and Updates: Anne Lewis provided an overview of the agenda and plans for the Annual Meeting, Sept. 7 – 9 in Memphis. The MN-MRPC will have four members attending. There will be a "State Dialogue Day" with each state assigned either a topic to present on, or to seek feedback on, followed by discussion and sharing to build the capacity of all state commissions. Technical committees will meet and will consider priorities and common projects. The National Caucus of Environmental Legislators will have a presence at the meeting as well. MRPC Culture & Heritage Committee: John Anfinson reported that Culture & Heritage Committee topics will be focus areas at the Annual Meeting.

MRPC Transportation Committee: Tim Wilcox reported that the committee is discussing United States Bicycle Route designation for the MRT in all ten states (MN already holds this designation); maintaining updated GIS files for the GRR route; online mapping of traveler resources; and supporting the Environment, Recreation and Agriculture Committee's efforts on pollinator habitat. Tim also announced that he will be leaving MnDOT to become a full-time firefighter. Sen. Senjem and commission members thanked Tim for his work with the MN-MRPC and wished him well in this new position.

Drive the Great River Road Month 2022: Mallory Forseth from the MN Department of Agriculture provided an update on plans for Drive the Great River Road Month, referenced the materials in the meeting packet and requested Commission member involvement. Members were asked to share the Facebook post announcing the Drive the Great River Road Month Kits available to the first 250 people who sign up on the special web form. Thanks were noted to all partners that provided the great items for the kits. There has been a lot of interest and 189 orders have already been received.

- Great River Road/Mississippi River trivia questions are needed.
- Prizes for the social media photo contest (#MNGRR) are needed. The prizes should be a little more than items in the travel planning kits but also not too expensive. Suggestions include things like a book, shirt, gift card or small collectible of some sort.
- MN-MRPC members are asked to watch the Minnesota Grown Facebook page for Great River Road Month posts, share and add information on their own regions, districts or agencies.
- An overview of Fall Harvest on the Great River Road and themed itineraries will be available at https://minnesotagrown.com/great-river-road/.
- A press event will be held at the Minnesota State Fair on August 30 at 10:00 a.m. A PR firm will be covering the press event, promoting stories and tracking media coverage.
- A news release will be going out to media and Great River Road partners and will also be shared with MN-MRPC members. Members were asked to help spread the word about the Fall Harvest/Drive the Great River Road Month campaign.

Commission Members Updates/Other Business:


- Karl Samp reported that the Brainerd Mississippi Trailhead Park is now under construction, including the amphitheater.
- John Anfinson reported that the U.S. Army Corps of Engineers will be kicking off a disposition study in September. The Corps will be seeking comments for their "scoping" of the disposition study and Environmental Impact Statement (EIS) for the Lower St. Anthony Falls Lock & Dam and Lock & Dam No. 1. During the scoping phase, the Corps asks the public to weigh in on all they think the Corps should address in the study and EIS
- Sally Fineday shared information on the video link that was provided to members with the meeting materials and encouraged members to watch it and discuss with others. The video on river conservation was done in 2021 when river levels were extremely low.
- Marni Karnowski announced transitions at MnDOT. She is in a new position as an Assistant Division Director for
 up to a year or longer. The Office of Environmental Stewardship position she left has not been filled yet, and
 Marni will continue on in her MN-MRPC role until a new appointment is made. She noted her appreciation for
 fellow Commission members and has enjoyed her time with the group. Chair Senjem and members thanked
 Marni for her service and look forward to continuing to work with her and others.
- Carol Zoff noted thanks to Marni Karnowski and Tim Wilcox and provided updates from MnDOT. A vendor that
 produced replacement interpretive panels for two locations along the Great River Road developed a case study
 that provides information about the Great River Road along with showing their panel product. The piece will be
 emailed out to members with the follow up from today's meeting. Boxuan Xia, a past student worker in the
 SEEDS program at MnDOT, is now studying for a master's degree, has used the MN Great River Road for a
 project and will be providing information on the results.
- Diane Henry-Wangensteen reported on MN-MRPC staffing. A new two-year agreement for services will soon be finalized with The Odyssey Group and Chris Miller will continue as the service provider.

- Represented MRPC at the State Fair Kick-Off for the Drive Month Campaign. Was impressed with the participation of so many of our state partners. Leaders from Transportation, Tourism, DNR, MNHS and Agriculture were on hand and participated in a good-natured contest, "Fun Facts about the Great River Road and Mississippi River". I don't remember who won, but I think John Anfinson was disqualified and David Kelliher may have walked away with the prize.



- Proud to attend MRPC National Meeting in Memphis and be both an executive officer, but also a member of the esteemed Minnesota delegation. Leading up to the Memphis meeting, I worked with MRPC staff and the staff of the National Caucus of Environmental Legislators' Mississippi River Caucus to co-locate our respective meetings and was able to award the caucus with the MRPC's Stewardship Award. The goal of networking more with NCEL fits our CMP and that of the 10-state organization and was first suggested by Minnesota's Chair Sen. Senjem.
- Led an American Queen Mississippi River Extension bus tour to the Headwaters Sept. 26. Two interesting things about this trip: This became an orientation for the whole river since it was at the beginning of the cruise. The tour boat on Lake Itasca failed to show up. I was able to suggest the group go to Bemidji where they were entranced with Babe and the Blue Ox, which I plugged as one of America's top-ten selfie locations. We were treated to a brief tour of the Watermark Art Gallery right across the street. Neither the driver, nor the tour director were aware of Bemidji and both commented positively on the selection, which took no time off the trip and added to the experience of the River.

Committee Chair Sabrina Chandler confirmed the focus on Environment (native pollinators), Recreation (Pollinator week bike ride), and Agriculture (agritourism).

Future ERA To Dos:

- 1. Environment: The ten state MRPC will likely be asking state MRPCs to ask GRR communities to pass resolutions supporting efforts to establish native pollinator habitat in the corridor. - 3. Agriculture: Committee was asked for success stories. I shared the Drive the Great River Road Month/Minnesota Grown story so there may be follow up questions. It appears National Office is going to continue to build the MRPC agritourism database. Information was shared on how Minnesota Grown locations are built into the MN GRR Plan Your Trip interactive map.

 - Derick Biglane (MN) Treasurer




 The Annual Meeting was held in collaboration with the National Caucus of Environmental Legislators, and we awarded the organization with the 2022 MRPC Stewardship Award.

Dear Colonel Swenson,

This letter is provided to share information about the Minnesota Mississippi River Parkway Commission's (Commission) mission and how that mission relates to the potential opportunities and impacts coming from the Lower Saint Anthony Falls Lock and Dam and Lock and Dam No. 1 Disposition Study.

As established under Minnesota Statute 161.1419, the Commission's mission is to promote, preserve and enhance the resources of the Mississippi River Valley and to develop the highways and amenities of the Great River Road, which, in February 2021, received All-American Road status. The Commission promotes, supports, and advances actions, responsibilities, procedures, controls, operational practices, and strategies to maintain the intrinsic archaeological, cultural, natural, historic, recreational, and scenic qualities that support National Scenic Byway Designation. The Commission's interest in the Disposition Study relates to these intrinsic qualities.

The Great River Road/All-American Road runs adjacent to the Mississippi River from St. Anthony Falls to the Minnesota River confluence at Fort Snelling. At St. Anthony Falls, the Mill City Museum is a designated Great River Road Interpretive Center as is Fort Snelling, which is a National Historic Landmark. The St. Anthony Falls Historic District features the Pillsbury A and Washburn A Mills, both of which are National Historic Landmarks, and the James J. Hill Stone Arch Bridge, a National Engineering Landmark. Given their connection to the history of Mississippi River navigation, the Lower St. Anthony Falls Lock and Dam and Lock and Dam No. 1 have been determined eligible for the National Register of Historic Places. With all the planning and projects already built to turn the St. Anthony Falls riverfront into a world-class visitor destination, the opportunities to inform and educate visitor about the Great River Road are immense.

The Commission encourages your consideration of comments submitted or being submitted by our member agencies (noted above) during the Scoping Phase as to all the matters and issues that the Corps should address in your study, including in the National Environmental Policy Act report. The more comprehensive and complete the Corps' studies are, the better the public, other agencies and the Commission will be able to understand and weigh in on the future of the Mississippi River in the heart of the Twin Cities. We also ask that you consider how your studies, recommendations and decisions may affect the Great River Road's intrinsic qualities.
